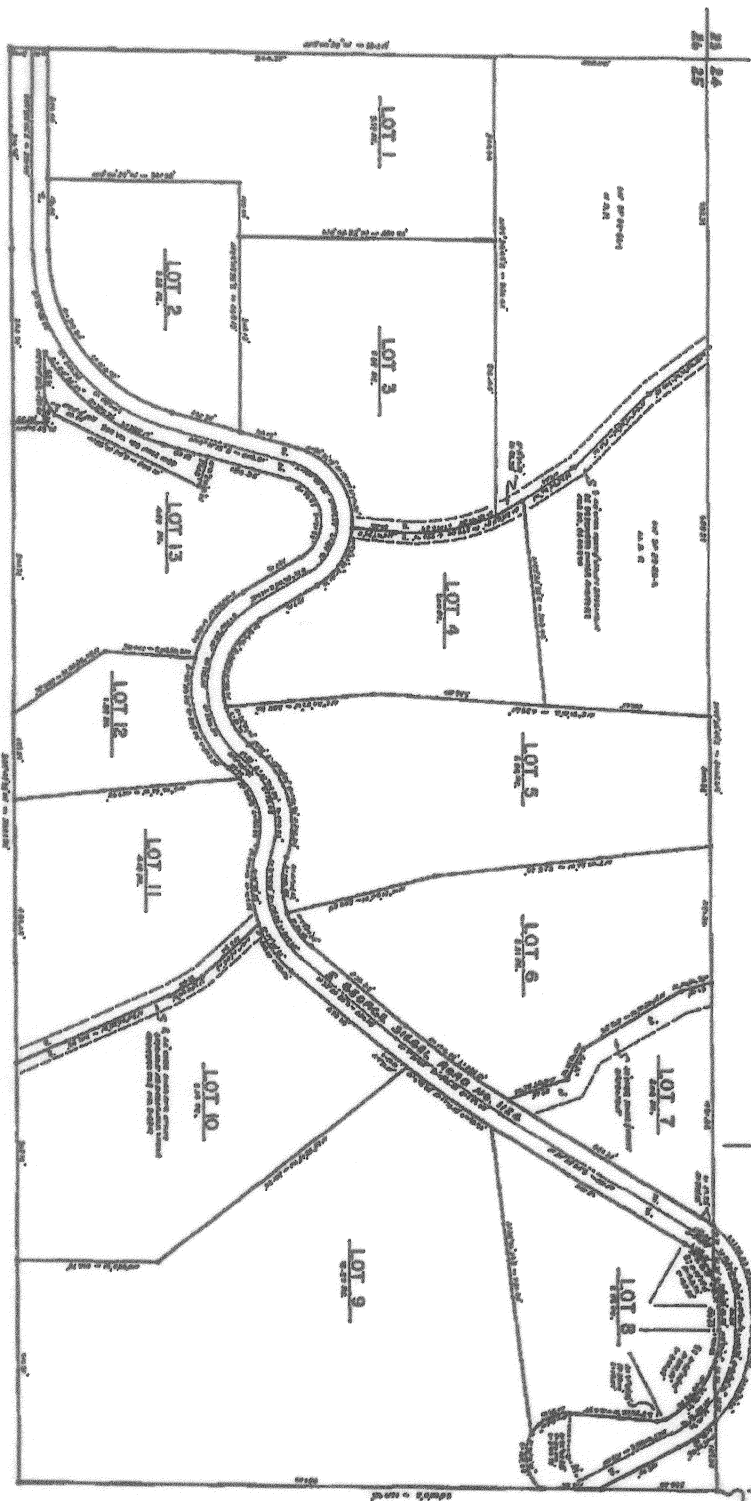


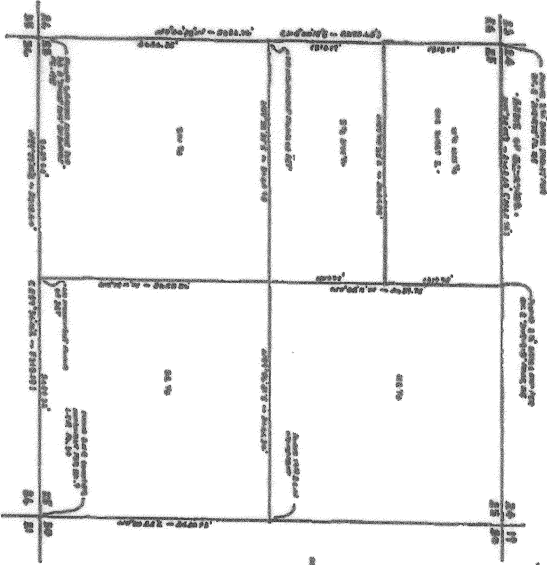
**SOUTHRIDGE ESTATES**
